PART I. GENERAL EXPECTATIONS

The **<u>Garland K-8</u>** agrees to implement the following statutory requirements:

- 5. The <u>Garland K-8</u> will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Principal e-mailing
 - Calling Parents
 - o Feedback forums after evening events or Coffee w/the Principal
- 6. The <u>Garland K-8</u> will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - *Results of assessments will uploaded in family Skyward account with access code to State of Texas assessment website.*
 - *Copy of assessments will be delivered to student to take home.*
- 7. The <u>Garland K-8</u> will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
 - Letter mailed via School Messenger to all affected families.
- 8. The <u>Garland K-8</u> will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:
 - Open House/Meet the Teacher Night
 - Curriclum Night
 - *Coffee w/the Principal*
 - Weekly Newsletter
- 9. The <u>Garland K-8</u> will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- Guest Speakers during PTO events
- o Anti-bullying informative sessions
- 10. The <u>Garland K-8</u> will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Encourage staff to attend web-based learning
 - o Monthly Home Visits
 - Encourage Staff to attend parent activities
 - o Provide school-based professional development
- 11.
